### A. Interest for Setting up NFR Facilities at GGL CNG COCO Stations

Gujarat Gas Limited (formerly known as GSPC Distribution Networks Limited), is India's largest City Gas Distribution entity with its presence spread across 44 Districts in the State of Gujarat, Punjab, Haryana, Madhya Pradesh, Rajasthan and Union Territory of Dadra & Nagar Haveli making GGL a PAN India Company.

GGL has India's largest customer base in Domestic, Commercial and Industrial segments. The company has more than 37,000 (Thirty-Seven Thousand) kms of gas pipeline network. It has more than 800 CNG stations and distributes approximately 9 mmscmd of natural gas to more than 20.25 lakh households, approximately 3.5 lakh CNG vehicles (serving per day) and to over 4,300 (Four Thousand and Three Hundred) industrial customers.

Gujarat Gas Limited (GGL) operates in the country's largest network of CNG stations in Urban, Highways & Rural market segment across Gujarat, Punjab, Haryana, Madhya Pradesh, Rajasthan and Union Territory of Dadra & Nagar Haveli India. Many of these CNG stations have built-up structures as well as open spaces available for non-fuel ventures. GGL is planning to develop non-fuel facilities and amenities on these fuel stations utilizing these assets for the convenience of the customers coupled with revenue generation. The main objective of setting up of NFR is to provide services of various categories to customers at a single doorstep.

With a view to provide outstanding driver and vehicle care and convenience to the customer at all COCO CNG Stations, we are actively pursuing an initiative to provide various value-added facilities and services through these facilities and have already introduced amenities such as Convenience Stores, ATMs, Branded Specialty Stores, Pharmacies, Fast Food etc. Our experience has shown that customers have received this NFR Initiative shopping solution very well and the overall response has been extremely encouraging.

GGL proposes to enter into arrangement with prominent organizations / experienced individuals of repute having experience of at least one year in successfully operating these NFR facilities.

As part this arrangement, GGL would allow the short-listed organization / individuals to operate these NFR Facilities for the convenience of our customers at the locations mentioned in the Annexure – I on monthly Fixed Facility Fee basis for a period of 3 (Three) years. GGL will have the option to renew it for another term of 3 (Three) years subject to satisfactory performance and revised commercial terms and conditions, to be negotiated then. However, GGL reserves the right for renewal of the arrangement. It is clarified that provision of space at GGL COCO CNG Station and permission by GGL to the successful bidder/vendor to sell goods and services, shall not create any interest in the GGL CNG COCO Station or any facility thereof. The said permission cannot be assigned to any other person/entity.

There will be lock-in period for 1 (one) year for the successful bidder.

### C. Objective

The objective of this TENDER document is to spell out the salient details of the proposed arrangement to enable organizations to respond to this TENDER to confirm their willingness to take up this activity and quote commercial offer for the same.

### **D. Proposed Activity**

As stated above, the activity proposed is to set up for NFR Facilities as proposed in the Tender at the locations mentioned here below in association with an organization / individual of repute having requisite experience.

### E. GGL's Scope:

On its part GGL will:

- 1. Provide necessary carved out space and superstructure for the NFR Facilities on as is where is basis
- 2. Allow the selected party to operate such NFR Outlet as described above at the premises of GGL COCO CNG Stations
- 3. Provide large customer base patronizing GGL COCO CNG Stations
- 4. Provide necessary utility connections with separate consumption meters
- 5. Provide necessary space for putting up Facility for visibility of as per GGL guidelines
- 6. Provide space at the CNG Stations for parking of customers' vehicles for a limited time of transaction, subject to availability
- 7. Consider co-branding of the NFR Facilities as per mutual agreement
- 8. GGL does not assure any business revenue commitment.

# F. Scope of the Selected Party

The Selected party, on its part shall:

- Pay Facility fees to GGL
- provide necessary manpower to run the NFR Facilities with a successful track record
- assume complete end-to-end responsibilities for running the NFR Facilities at selected GGL COCO CNG stations
- Implement necessary operating systems and provide necessary manpower for operating the NFR Facilities.
- Make necessary working capital investment in the facilities.
- Obtain necessary licenses and approvals for operation of such facilities and sale of goods and services
- Provide the entire range of related items for sale at the facilities in line with the customers' requirements with the greatest attention to aspects related to health, hygiene & aesthetics
- Start the operation of the NFR Facilities within 30 days of receipt of firm offer from GGL.
- Bear all expenses towards consumption / use of electricity & water as indicated by separate meters.
- Ensure that no interest (including third-party interest) is created at GGL COCO CNG Station premise by virtue of the Agreement. The overall management, control and occupation of premises shall be the sole responsibility of the selected party. Accordingly, license to do the business at the premise will be with the selected party with whom GGL has entered into an Agreement.
- Pay service tax/GST at the applicable rate
- Take and maintain adequate insurance for its goods and other assets
- Comply with HSE policy of GGL and ensure that its employees and contractors follow the safety guidelines and not create any obstruction or nuisance
- Ensure cleanliness and hygiene
- Reimburse incremental property taxes (if increased because of the operator's newly commissioned convenience or specialty stores) to GGL and charges for the sign board (if any) to the local statutory bodies (as applicable).
- The external branding must be provided at the spaces confirmed by GGL in writing.

### G. Mode of Operation

Pursuant to the bidding process, GGL may decide to select the successful party to run the NFR Facility at CNG station. In case GGL so decides, an agreement, containing the terms and conditions of operation of NFR Outlet at the subject locations, will be signed between the GGL and the successful bidder. This agreement shall be initially for a period of 3 (Three) years. GGL will have the option to renew it for another term of 3 (Three) years subject to satisfactory performance, considering the success of the NFR Outlet, the efforts put in to develop the brand image and the impact on the fuel retailing business of the GGL CNG Stations. All Terms & Conditions governing the operation of the NFR Facilities shall be included in the agreement.

For each identified location, competent officers of GGL shall issue a specific authorization for establishment of NFR Outlet at that location in line with the terms and conditions contained in the agreement.

# H. Bidder Qualification Criteria (BQC)

Technical Bids:

- a. The bidder should be registered in/citizen of India.
- b. The bidder should be engaged in similar NFR Facilities (as selected) business with a minimum experience of 1 (One) year.
- c. Should have experience of running at least one such store/facility in GGL Authorized areas as mentioned above.
- d. Should be a reputed brand name in the state, where they have been operating.
- e. Should in-principle agree with the terms and conditions mentioned in the enclosed draft agreement

Commercial Bids:

- a. Quotes should be mentioned for 3 (Three) years on Lump sum per month basis.
- b. In case based on the above evaluation criteria, two or more bids become equal; weightage will be given on the first year's Monthly Rent quoted.
- c. Please note that the quote for 3 (Three) years should be equal or in incremental order only. Quotes with negative increment are liable for rejection.

Bid is liable to be rejected if the credential offer contains commercial offer. <u>Commercial Offer</u> should be submitted in a separate sealed envelope.

Please note that:

- GGL reserves the right to amend, rescind or reissue this TENDER any time after issuance at its discretion. Amendments, if any, will be advised to all recipients of the TENDER document by courier/fax and shall be binding on them.
- GGL reserves the right to accept any proposal and reject any or all responses to this TENDER without assigning any reasons for the same with no penalty to itself.
- GGL will evaluate the proposals following such methods, criteria and rationale, which in its, opinion, are in the best interest of GGL.
- Proposals received pursuant to this TENDER will become the property of GGL and shall not be returned.
- If the Commercial offer is lower than their expectation, GGL may or may not, in its absolute discretion, negotiate with the highest bidder.

#### **Other Points:**

 Declaration on letter head confirming "In-Principle Agreement" on general terms and conditions (other than commercial terms), as mentioned in the enclosed draft agreement, please refer Annexure – 3 Proposed external branding superimposed on photograph of the existing structure. Operator to note the branding shall be finalized in line with GGL guidelines.

#### I. Documents to be submitted

- 1. Tender document and terms & conditions (each and every page) duly filled, signed and stamped by the agency along with the supporting Documents.
- 2. Agency Registration certificate from appropriate authority.
- 3. Audited copy (including balance sheet and P&L) of the annual turnover for last 1 (One) year should be submitted.
- 4. Copy of PAN Card number issued by the Income-tax department.
- 5. Copy of GSTIN
- 6. Income tax return of last 3 (Three) years (certified copy is to be submitted with application).
- 7. Details of NFR related Work (Work order, completion certificate) executed for the last 1 (One) financial years for Govt., Public undertaking organizations, Private companies.
- 8. Memorandum of Association, Articles of Association and Certificate of Incorporation in case if the bidder is a Company.
- 9. Registered Partnership Deed in case the bidder is a Partnership Firm.

Subsequent to evaluation, GGL may reject or accept the bid submitted by the bidders. GGL reserves its right to disclose or not disclose the outcome of the bidding.

GGL may declare the successful bidder, who will have to sign the Commercial Agreement. Format of the Commercial Agreement will be shared by GGL. Successful bidder shall also have to submit 6 (six) months' rent deposit by way of cheque drawn in favour of GGL.

### **N.** TERMINATION AND EFFECT OF TERMINATION:

- 1.1 GGL reserves the right to terminate the CONTRACT/Agreement either in whole or in part, upon occurrence of one or more of the following events by giving 15 days' notice in writing to the VENDOR:
  - a. Breach of contractual obligation by the VENDOR
  - b. Insolvency or bankruptcy of the VENDOR, or, entering into receivership, administrative receivership, administration or liquidation (or any equivalent thereof) whether compulsory or voluntary, except liquidation for the purpose of reconstruction or amalgamation while solvent.
  - c. Failure to fulfil any of the VENDOR's obligations under the CONTRACT/Agreement
  - d. Failure to commence the sale of goods and services even after 60 days of Contract/agreement

If for any reason the Successful Bidder fails to start the business even after lapse of 30 (thirty) days from the effective date/Agreement date, GGL may at its own discretion, may consider deduction from the deposit, and in case even after the deduction and/or notice, there is no commencement, GGL may reserve its right to terminate the agreement plus forfeiture of the entire security deposit.

The decision of GGL regarding occurrence of any of the aforesaid events shall be final and binding on the PARTIES.

- 1.2 Without prejudice to, and in addition to, GGL's other rights under this CONTRACT; GGL shall have the right to terminate CONTRACT or any part thereof without assigning any reason at any time by giving 24 hours written notice to the VENDOR.
- 1.3 The VENDOR shall be responsible for, indemnify, defend and hold harmless GGL against any and all costs, expense incurred by the GGL and any claim, proceedings, brought against GGL by any entity due to or owing to the goods and merchandise sold or services provided by the Vendor from the GGL CNG Station. In case GGL has to incur expenses due to the same, the same shall be recovered from the VENDOR and / or security deposit held with GGL.
- 1.4 There shall be no agency between GGL and the Vendor, and the Vendor shall do its business at its own cost and risk.
